## **Deliberation of Advisory Group Recommendations**

- 1. The Advisory Committee commended the Commemoration staff efforts to engage Speaker of the House staff to coordinate and develop a Congressional Ceremony in 2015. The Advisory Committee recommended that we allow ample time (6-7 months) to plan and prepare for this very significant ceremony. The Advisory Committee deliberated on how they can assist us in getting greater Congressional support for the Commemoration Program and will assist in making contact with the relevant Congressmen and Congresswomen.
- 2. Advisory Committee member Paul Bucha cautioned against engaging so-called veteran identification companies, of which there are about 10 to 15, who say they will verify a veteran's military record but in fact are gathering data on the veteran and selling it.
- 3. Mr. Bucha also recommended that we assist the Gold Star Mothers in getting greater support from Capitol Hill to attend their annual event, and that we build a strong bond with the Gold Star Mothers as this should be part of our legacy.
- 4. The Advisory Committee recommended that the Commemoration develop a strategic communication plan. Specifically, the Chairman explained that the strategic communication plan should synchronize our message with the multiple veterans' organizations who have their own internal communications (newsletters, websites, blogs) and coordinate that activity on a consistent basis over the next two or three years to highlight what we're doing.
- 5. Advisory Committee member Mr. Dick Anderegg recommended that the Advisory Committee select a Vice-Chairman to chair these meetings in the absence of the Chairman. All committee members agreed and will discuss at the next meeting.
- 6. The Chairman proposed the Advisory Committee convene the next meeting sometime in late January or early February and look to provide teleconference capability for those members who cannot make the meeting.
